Legal Authority and Purpose of Filing:

This filing is made under the authority of <u>Faretta v. California</u>, <u>Haines v. Kerner</u>, and <u>Erickson v. Pardus</u>, and must be liberally construed in favor of the pro se Defendant. All filings are made without waiver of counsel, and under special appearance, reserving all jurisdictional objections.

Evidentiary Clarification and Offer of Proof:

This Affidavit/Declaration is not offered as "new evidence", but as a corrective proffer to supplement and clarify the existing record. It represents what Defendant would have truthfully testified to at trial or sentencing but for counsel's unconstitutional conduct, including requiring Defendant to provide false testimony and failing to prepare or permit accurate testimony.

This filing is made pursuant to Tennessee Rule of Evidence 103(a)(2) (offer of proof) to preserve the evidentiary record, and to support constitutional claims of ineffective assistance of counsel under <u>Strickland v. Washington</u>, 466 U.S. 668 (1984), and violation of the Defendant's right to testify under <u>Rock v. Arkansas</u>, 483 U.S. 44 (1987). The Affidavit also supports post-conviction

review under Tenn. Code Ann. § 40-30-103, and conforms to procedural fairness under Tennessee Supreme Court Rule 28 § 9.

The Defendant asserts that he was permitted to testify, but was compelled to provide false testimony due to defense counsel's coercion, thereby violating his right to testify fully and truthfully and undermining the adversarial process. Such conduct constitutes a structural violation affecting the fundamental fairness of the proceedings.




